Sales to NGOs and governments are discounted in DKT's CYP numbers but accounted for in full in health impact data in each country's estimates.

WomanCare sales cover sales to more than 100 countries. Sales by WomanCare to other DKT offices are discounted to avoid double-counting.

*Estimates of child death based on relative associations between contraception prevalence rate, birth spacing and child mortality- estimates may be unreliable due to limited data.
